## a resource list

### Introduction

A published thesis may be helpful for research in various ways, for example, in finding areas for further research; simply to use information from the thesis; for comparative purposes; to learn of relevant historical sources; to look at methodology, and so on. Theses were once available only in print, but are now often being digitised and many are available online.

This list is of doctoral and masters theses (and a few undergraduate dissertations) from the 1970s onwards. It is not necessarily complete – notice of omissions welcome to [librarian@mininginstitute.org.uk](mailto:librarian@mininginstitute.org.uk).

### Information sources used to compile the list.

#### EThOS

The main source of information on doctoral theses is the British Library's *E-Theses Online Service* (EThOS) at <http://ethos.bl.uk>. (Details of the database at <http://www.bl.uk/reshelp/findhelprestype/theses/ethos/>)

This lists over 400,000 theses, some of which can be downloaded immediately without charge (after registration) and most of the others can be requested to be scanned and then made available – sometimes at a small cost.

#### Research repositories

Most universities have a repository of research publications – conference papers, preprints, masters and doctoral theses, maybe undergraduate dissertations, and so on – that are free to download. The OpenDOAR service (<http://www.opendoar.org/search.php>) allows searching across many repositories from around the world.

#### History online (<http://www.history.ac.uk/history-online/theses>)

The Institute of Historical Research, University of London, has a browsable and searchable directory of history theses completed from 1970 onwards, as well as current research in progress. It does not link to the full text of theses.
